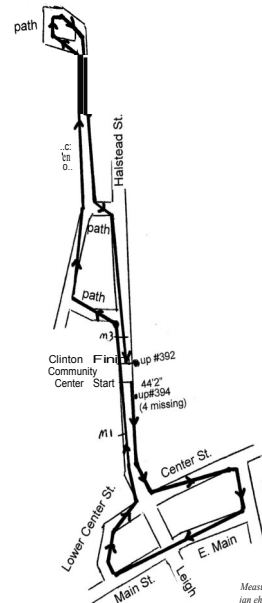

Start: On Halstead St., 44 feet 2 inches north of utility pole #394 (4 is missing) on the east side of the road which is at the garage to house #56 on the left.
Mile 1: On Halstead St., running northbound after the loop in Clinton, 34 feet 6 inches after utility pole 401 on the right and at the trailing edge of the driveway to #23 on the left.
Mile 2: On park path before the northern turnaround, 6 feet 8 inches before the 8th guard rail post on the left counting from the north end.
Mile 3: On Halstead St., 15 feet 7 inches before the blue PVC pipe stand on the right.
Finish: On Halstead St., at utility pole #392 on left which is across the street from the Clinton Community Center.

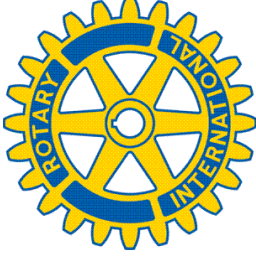
